OFFICE ORDER

This is with reference to non-employment declaration to be submitted by retired employees for availing medical benefits under Post Retirement Medical Benefit (PRMB) Scheme. As per instructions in vogue, in order to avail medical under PRMB Scheme, all retired employees have to submit declaration in the month of January every year stating that they have not taken up regular full time employment outside ONGC.

It is thus enjoined upon retired employees to submit the non-employment declaration which is made digital on www.bandhan.ongc.co.in, in January 2023 to continue with their medical facilities.

For beneficiaries who are availing medical after the demise of the retired employees, format attached at Annexure -1 may be filled in and submitted to their respective I/c SEE in hard copy.

On taking up regular full time employment outside ONGC, retired employees should immediately inform about the employment and the employee shall not avail medical from ONGC. Failure to inform ONGC within a month of taking up regular full time employment shall debar them from availing medical facility under PRMB Scheme.

Declaration under PRMBS(to be submitted in January)**(for beneficiary after demise of retired employee/ in demise cases of employees)**

1. I(name), am the (spouse/child/parent/parent -in-law) of ONGC ex-employee Late(name), CPF no , who separated from ONGC on(superannuation /retirement/VRS/demise) and I am a member of ONGC Post Retirement Medical Benefit Scheme.
2. I declare that I am not employed and I am not married or re-married.
3. I do further solemnly declare that when I will take up employment/ get married or remarried, I shall immediately inform ONGC.
4. I solemnly affirm that the above declaration is true to the best of my knowledge and belief. I understand that in the event of the declaration being found to be incorrect at a later date or failure to inform ONGC within a month of taking up employment/ getting married or remarried, I shall be liable to be debarred from availing medical facility under ONGC Post-retirement Medical Scheme.
5. This declaration is given for the purpose of extending medical facility under PRMB Scheme.
6. The declaration is also given to extend medical facilities to the following dependents of the Late ex-employee :
 - a. Dependent parents/parents –in-law:.....(name)

 - c. Child with disability :.....(name)

Note: In case child with disability who is not able to give the declaration and is the only beneficiary availing medical facility, then the declaration can be given by a legal guardian.)
